- c) The object of the company is the pursuit in Italy and abroad of the following activities:
  - development, construction, trading, sale and installation, maintenance and technical assistance of electrical and electronic equipment, software, switchboards and electrical installations, control and automation systems for electrical installations, materials and systems for electrical installation in industrial and civil installations, metal carpentry and related products, insulating material components, as well as mechanical machining in general;
  - development, production, marketing, sale, installation and technical assistance of products, tools and systems related to the automation, regulation, analysis and control of industrial processes and all their applications, and the provision of services relating to ancillary activities;
  - development, manufacture, trading, technical assistance and maintenance of components, machines, instrumentation and electrical, electromechanical, electronic and automation systems, their implementation and all their applications;

  - supply of telecommunications equipment and networks services, as well as the purchase, development, ownership, sale and marketing of telecommunications, telematics, multimedia and electronic products, services and systems, and the connection and/or interconnection of the various networks;
  - coordination of basic and applied technological research for the development of new materials, products and production processes in the fields of electrical engineering, electronics, information technology, communication and environmental protection, as well as the consequent management of intellectual property rights;

The company may receive financing from its members and provide financing to the subsidiaries, in compliance with the applicable laws and regulations from time to time. The company may also carry out any related and/or attributable to the aforementioned social purposes.
